



# LIMITED WARRANTY

## Endless Pools® RecSport Recreation System

Watkins Wellness (“Watkins”) warrants from the date of installation to the original consumer purchaser (“you”) the following when your new RecSport Recreation System by Endless Pools® is purchased from an authorized dealer/service provider (“dealer”).

**10 Year No Leak Shell Warranty**  
Watkins warrants the shell of the RecSport Recreation System to be free from defects in material and workmanship resulting in water loss for ten years.

**5 Year Shell Surface Warranty**  
Watkins warrants the acrylic shell surface of the RecSport Recreation System to be free from defects in material and workmanship for five years. Your spa shell is made of plastic, thermoformed material that naturally ages over time, which may result in minor cosmetic imperfections, including fading, discoloring or surface anomalies that are not covered by this warranty.

**3 Year No Leak Plumbing Warranty**  
Watkins warrants the plumbing of the RecSport Recreation System to be free from leaks caused by defects in material and workmanship for three years. This warranty specifically covers leaks from the wall fittings, jet fittings, internal plumbing, internal glue joints, drains, hoses, and all bonded parts.

**3 Year Component Warranty**  
Watkins warrants the electrical components, pumps, jets, air valves, levers, bezels and other RecSport Recreation System components to be free from defects in material and workmanship for three years. Some parts, most of which can be changed out without the use of tools, (i.e. filter cartridges, filter lids, and cover locks) are not included in this warranty but are warranted to be free from defects in material and workmanship at the time of delivery. System covers and other accessories are excluded from this warranty, although they may be covered by other warranties. Please check with your RecSport Recreation System dealer for details.

**3 Year Heater Warranty**  
Watkins warrants the factory installed heater in the RecSport Recreation System to be free from defects in material and workmanship for three years. This warranty does not cover commercial or industrial use systems, and those that have been improperly installed.

**3 Year Cabinet Warranty**  
Watkins warrants the RecSport Recreation System cabinet material to be free from defects in materials and workmanship for three years. This warranty specifically covers the cabinet’s structural integrity (exclusive of surface stain), including the material and assembly.

**1 Year Light Assembly Warranty**  
Watkins warrants the light assemblies, which includes underwater and exterior lighting to be free from defects in material and workmanship for one year.

**1 Year Water Sanitation Warranty**  
Watkins warrants the RecSport Recreation System electrical components, ozone tubing, check valve, injector, corona discharge cell and exterior housing of the corona discharge ozone purification system against defects in material and workmanship for one year. UVC light bulb is not included as part of the Water Sanitization Warranty

The following applies to all of the warranties listed above:

### Extent of Warranty

This warranty extends only to the original consumer purchaser of the RecSport Recreation System when purchased and originally installed within the country of purchase. This warranty begins on the date of installation of the system, but in no event later than one year from the date of purchase. This warranty terminates upon any transfer of ownership, or if the system is installed or relocated outside the country of purchase prior to the expiration of the warranty period. Service under this warranty does not extend the warranty period.

### Warranty Performance

To make a claim under this warranty, contact the dealer where you purchased your system. In the event you are unable to obtain service from your dealer, please write Watkins at 1280 Park Center Drive, Vista, California, 92081, Attn: Customer Service Department or call (800) 999-4688 or via e-mail, [customerservice@watkinsmfg.com](mailto:customerservice@watkinsmfg.com). You must give Watkins, and/or your dealer written notice of any warranty claim, along with a copy of your original purchase receipt indicating the date of the purchase, within thirty (30) days of the time you discover the claim. Watkins reserves the right to inspect the malfunction or defect on location.

Watkins or its Authorized Service Agent will repair any defects covered by this warranty. Except as described herein, you will not be charged for parts and/or labor necessary to repair the system for defects covered by this warranty. In some cases, the servicing dealer may charge you a repairperson travel/service charge that is not covered by this warranty. Please contact your dealer for information regarding any such charges.

### Limitations

Except as described above, this warranty does not cover defects or damage due to normal wear and tear, improper installation, alteration without Watkins prior written consent, accident, acts of God, misuse, abuse, neglect, use of an accessory not approved by Watkins, failure to follow Watkins Pre-Delivery Instructions or Owner’s Manual, or repairs/installations made or attempted by anyone other than an authorized representative of Watkins. Alteration includes, but is not limited to, any component or plumbing change, or electrical conversion. Please contact your dealer for a list of manufacturer approved accessories.

This warranty does not cover industrial or commercial applications, including installations in property used for long-term or short-term rental.

**TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THIS WARRANTY DOES NOT COVER INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING BUT NOT LIMITED TO THE REMOVAL OF ANY DECK OR CUSTOM FIXTURE OR ANY COST TO REMOVE OR REINSTALL THE SYSTEM, IF NEEDED.** Some states, provinces or countries (including Quebec) do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations may not apply to you.
